*Title.*

A Law to make provision for the sum of **₦169,557,658,300.00 (One Hundred and Sixty Nine Billion, Five Hundred and Fifty Seven Million, Six Hundred and Fifty Eight Thousand, Three Hundred Naira)** to the services of the Government of Enugu State of Nigeria for the year ending **Thirty First Day of December, Two Thousand and Twenty** and for other related purposes.

*Date of commencement.*

**(1<sup>st</sup> January, 2020)**

*Preamble*

**WHEREAS -**

The Government of Enugu State of Nigeria deems it necessary that the sum of **₦169,557,658,300.00 (One Hundred and Sixty nine Billion, Five Hundred and Fifty seven Million, Six Hundred and Fifty eight Thousand, Three Hundred Naira)** be applied and expended for the services of Enugu State for the year ending 31st December, 2020 as set forth in the schedules to this Law.

*Enactment.*

**Be it enacted** by the Enugu State House of Assembly as follows -

*Citation.*

**1.** This law may be cited as the Enugu State of Nigeria Appropriation Law, 2020.

*Recurrent Expenditure of ₦68,790,000,000.00 out of the Consolidated Revenue Fund.*

**2.** The Accountant-General, shall on the warrant of the Commissioner responsible for matters relating to budget, given after obtaining the consent of the Governor, or any person specifically authorized by the Governor in that

behalf, pay out of the Consolidated Revenue Fund of Enugu State of Nigeria during the year ending 31st day of December, 2020, any sum not exceeding in the whole the sum of **₦68,790,000,000.00 (Sixty Eight Billion, Seven Hundred and Ninety Million Naira)** being the total of the amount provided for Recurrent Expenditure as set forth opposite organization codes:

4. 4. The Accountant-General, shall on the warrant of the Commissioner responsible for matters relating to budget, given after obtaining the consent of the Governor, or any person specifically authorized by the Governor in that behalf, pay out of the Consolidated Revenue Fund of Enugu State of Nigeria during the year ending on 31st December, 2020 any sum not exceeding in the whole the sum of **₦100,767,658,300.00 (One Hundred Billion, Seven Hundred and Sixty seven Million, Six Hundred and Fifty eight Thousand, Three Hundred Naira)** being the total of the amount provided for Capital Expenditure as set forth opposite organization Codes:




